

- 1- Sealed Tenders must be dropped in the box placed in jail premises on **03-03-2022, Thursday** latest by 11:00 AM which will be opened on the same day at 11:30 AM in the presence of the Committee and Contractors or their authorized representatives who opt to be present at the time of opening of sealed tenders along with call deposit/earnest money of **Rs. 10,00,000/- (Rs. Ten Lacs)** (Refundable) will be mandatory, in case of no call deposit the tender form will be rejected on the spot.
- 2- Details/ specifications of the items are available on the tender forms which can be obtained from the office of the Superintendent Headquarters Prison Peshawar without producing call deposit on any working day during office hours till **03-03 -2022, Thursday** before 10AM after which no tender form will be issued. The same may also be downloaded from the official website of KPPRA ([www.kppra.gov.pk](http://www.kppra.gov.pk)).
- 3- Rates will be valid till **30-06-2022**.
- 4- Taxes will be deducted from bills of the supplier according to prescribed rates.
- 5- Tenderers will have to produce samples of all the above articles at the time of opening of tenders without which tenders will be summarily rejected by the Committee.
- 6- Payment of all the above items will be made after satisfaction of the Committee.
- 7- In case of failure in making timely supply or supply of sub standard articles or failure to abide by the rules/terms & conditions of contract, the defaulting firm/contractor will be black listed and its earnest money/security will be forfeited to the state besides levying of fine after due process.
- 8- Superintendent Headquarter Prison Peshawar or the Committee reserves the right to reject the tender of any firm/ contractor before acceptance of the bid/ proposal wholly or partially by communicating grounds of rejection upon request.
