Sealed Tender for supply and complete installation of Surveillance (CCTV) Camera Security System with complete related hardware and NVRs Equipments, Device, Networking; Cabling, Recording System for use of this jail from the contractors / Firms/ Companies/ registered with Khyber Pakhtunkhwa Peshawar are invited for the Financial Year 2021-22. Tender Documents along-with specifications etc of the required items can be obtained from the office of the undersigned till 13th June 2022 (Monday till 10:00 AM) Articles/items will be supplied during the financial year 2021-22 on F.O.R Jail gate basis. The same may also be download from the official website of KPPRA (www.kppra.gov.pk). The estimated cost of the tender is Rs. 8,67,000/-.

1. Details/specifications of the items are available on the tender forms which can be obtained from the office of the Superintendent Central Prison Peshawar without producing call deposit on any working day during office hours till 13-06-2022 (Monday) before 10 AM after which no tender form will be issued. The same may also be downloaded from the official website of KPPRA (www.kppra.gov.pk). Rates will be valid till 30-06-2022.
2. Tender Form/ Tender documents alongwith specification of required items (duky completed) in sealed envelopes must be dropped in the box placed in jail premises latest by 10:00 AM on 13-06-2022 (Monday) after which no tender will be received. And along with tender documents, earnest money amounting to Rs. 17000/- in the shape of call deposit in the name of the Superintendent Central Prison Peshawar is obligatory. In the absence of earnest money, tender of the concerned firm/ contractor will be rejected.
3. Sealed Tender will be opened at 11:00 AM on 13th June 2022 (Monday) in the office of the Superintendent Central Prison Peshawar in the presence of the Committee and tenders/their authorized representatives who opt to be present.
4. The competent authority will approve the items based on the lowest price offered.
5. In case of supplying substandard goods or items, earnest money shall be confiscated.
6. Taxes will be deducted from bills of the suppliers according to prescribed rates.
7. Tenders will have to produce samples of all the above articles at the time of opening of tenders without which tenders will be summarily rejected by the Committee.

8. Payment of all the above items will be made after satisfaction of the Committee.

In case of failure in making timely supply or supply of sub standard articles or failure to abide by the rules / terms & condition of contract the defaulting firm/ contractor will be black listed and its earnest money/security will be forfeited to the state besides levying of fine after due process.
 10. Superintendent Central Prison Peshawar or the Committee reserves the right to reject the tender of any firm/contractor before acceptance of the bid / proposal wholly or partially by communication grounds of rejection upon request.
 11. Final approval of the rates/contract will be accorded by the competent authority.
