A meeting was held on the cited subject under the Chairmanship of Additional Inspector General of Prisons/Project Director Khyber Pakhtunkhwa at his office on 05.12.2022 at 02:00 PM. (Lists of Participates are attached)

Agenda of the meeting was to open the Financial Bids of the following firm, declared technically qualified by the Technical Committee:-

- M/S. ZEESHAN TRADERS PESHAWAR.
- 02. The Chairman welcomed the participants and apprised that in response to the Re-Tender Notice published on 15.10.2022 for inviting tenders for Wood Working Machinery/equipments to be purchased/ installed at Wood Working Centre at Central Prison Haripur, 03 Firms submitted bids/ proposals. Technical Bids were opened by the Procurement Committee in its meeting held on 03.11.2022 and complete evaluation was carried out by the Technical Committee in its meetings held on 07.11.2022 and 17.11.2022. Out of 03 Firms, M/S. Zeeshan Traders Peshawar was declared technically qualified and recommended for Financial Bid Opening. 03. Afterwards, the procurement Committee opened the Financial Bid submitted by MS. Zeeshan Traders Peshawar. The Committee carried out detailed assessment of the Financial Bid and it was found that overall Bid Cost of the machinery items of Rs.11,116,160/- exceeded the PC-I Cost of Rs. 10,813,000/-. Therefore, prices were negotiated as per KPPRA Rule (42A. Provision for negotiations on price) with the representative of M/S. Zeeshan Traders. The vendor i.e M/S. Zeeshan Traders has submitted Revised Financial Proposal, many thereby offering discount on
- The Financial Proposal with reduced cost/ discount offered by MS. Zeeshan Traders was examined with 04. due diligence and found rationalized in light of the prevailing price hike in the market for machinery items. After detailed discussion, the following decisions were made unanimously:

- Final Evaluation Report (Technical + Financial) was prepared and signed by the Committee Members.
- The Committee recommended M/S. Zeeshan Traders for Award of Contract with Financial Proposal at reduced cost as per Annexure 'A'.

The Draft Contract Agreement was approved by the Committee.
