MINUTES OF THE MEETING OF THE PROCUREMENT COMMITTEE FOR FINANCIAL BID(S) OPENING FOR THE PURCHASE OF IT EQUIPMENTS FOR THE INSPECTORATE GENERAL OF PRISONS KHYBER PAKHTUNKHWA PESHAWAR.

A meeting of the Procurement Committee was held on the cited subject under the Chairmanship of Additional Inspector General of Prisons Khyber Pakhtunkhwa at his office on 20.01.2023 at 02:30 PM attended by the Committee members and representatives of the Firms applied for various IT Equipments. (Lists of Participants are attached).

Before closing date and time, the following firms submitted their bids proposals:

- World Wide Associates Peshawar
- Shirazi Trading CO. Peshawar
- AURSoft Private Limited Peshawar
- Quick Business Solution Peshawar

Agenda of the meeting was to open the Financial Bids of the above firms and carry out its evaluation as per the approved criteria and other terms and conditions mentioned in the bids solicitation documents.


02. The Chairman welcomed the participants and apprised that in response to the Tender Notice published on 04.01.2023 for inviting Tenders for IT Equipments to be purchased for the Inspectorate General of Prisons Khyber Pakhtunkhwa Peshawar, 04 Firms submitted Bids/ Proposals. Financial Bids were opened by the Procurement Committee in presence of the representatives of the firms.

03. Afterwards, the forum was opened for discussion. All the Committee members gave their expert input and complete assessment and scrutiny of the bids were carried out by the Procurement Committee. After detailed discussion, the following decisions were made unanimously:


Decisions:


- Final Comparative Statement was prepared and signed by the Committee Members as Annex (A).
Decision for Computer System & LEDs:
- The comparative statement shows that the rates offered for Computer Systems & LEDs by M/S. Quick Business Solution Peshawar are comparatively the lowest and reasonable, therefore, recommended for award of Contract for Computer Systems & LEDs.
Decision for 650 VA UPS:
- The comparative statement shows that the rates offered for 650 VA UPS by World Wide Associates, are comparatively the lowest and reasonable but they have not provided authorization/ dealership Certificate, therefore, the Committee disqualified the World Wide Associates and recommended the next firm i.e AURSoft Private Limited Peshawar for award of contract for 650 VA UPS.
Decision for Photocopier (Heavy Duty):
- The comparative statement shows that the rates offered for Photocopier (Heavy Duty) by World Wide Associates, Peshawar are comparatively the lowest and reasonable but their specifications are below than the advertised specifications. Moreover, they have also not provided authorization/ dealership Certificate, therefore, the Committee disqualified the World Wide Associates and recommended the next firm i.e Shirazi Trading CO. Peshawar for award of contract for Photocopier (Heavy Duty).
Decision for Photocopier small size:
- The comparative statement shows that the rates offered for Photocopier small size by Shirazi Trading CO. Peshawar are comparatively the lowest and reasonable, therefore, recommended for award of contract for Photocopier small size.





- For 650 VA UPS:** The above comparative statement shows that the rates offered for 650 VA UPS by World Wide Associates, are comparatively the lowest and reasonable but they have not provided authorization/ dealership Certificate, therefore, the Committee disqualified the World Wide Associates and recommended the next firm i.e AURSoft Private Limited Peshawar for award of contract for 650 VA UPS.
- For Photocopier (Heavy duty):** The above comparative statement shows that the rates offered for Photocopier (Heavy Duty) by World Wide Associates, Peshawar are comparatively the lowest and reasonable but their specifications are below than the advertised specifications. Moreover, they have also not provided authorization/ dealership Certificate, therefore, the Committee disqualified the World Wide Associates and recommended the next firm i.e Shirazi Trading CO. Peshawar for award of contract for Photocopier (Heavy Duty).
- For Photocopier Small Size:** The above comparative statement shows that the rates offered for Photocopier small size by Shirazi Trading CO. (PVT.) LTD Peshawar are comparatively the lowest and reasonable, therefore, recommended for award of supply order for Photocopier small size.
