
I am further directed to convey that:-


- Supply of the cooked food may be obtained from the contractor / supplier concerned according to the required standard having 1st quality as per prescribed scale / menu and no deviation is allowed at any cost.
- Security / call deposit should be obtained from the successful contractor strictly as per rules.
- Agreement deeds should be executed with the contractor concerned within a week time positively on the receipt of this letter and sent to this office at the earliest.
- Medicines may be purchased from the approved firm of Government MCC of Health Department on their approved rates. However, essential nature medicine may be purchased on quotation basis after observing all legal and codal formalities under the rules.
