- i. Minutes of the meeting of Procurement Committee and Comparative statement may be got countersign from the Deputy Commissioner or Additional Deputy Commissioner (F&P) and sent to this office within 7 days positively.
- ii. Written consent/application regarding reduce of rates of contractor Jaffar Iqbal may also be got signed from the Procurement committee and sent to this office within 7 days positively.
- iii. The rates tendered by contractor for supply of Energy Sever, Phenyl, Bamboo Tillies, Lime-Unslacked and Mustard oil found too high. Therefore, these items may be purchased strictly in accordance to rules.
- iv. Supply of the cooked food may be obtained from the contractor /supplier concerned according to the required standard having 1st quality as per prescribed scale /menu and no deviation is allowed at any cost.
- v. Security should be obtained from the successful contractor strictly as per Rules.
- vi. Agreements deed should be executed with the contractor concerned within a week time positively.
- vii. Medicines may be purchased from the approved firm of Government MCC of Health Department. However, essential nature medicine may be purchased from
